**\*The City of Lufkin is not responsible for damage to drives, parking lots, sites or vehicles.\***

### **The following shall be in effect:**

1. Rental period is from Friday morning until Monday morning, or from Monday morning until Friday morning. Rental fee for each period will be \$50.00 plus tax.
2. The six-yard, Litter Critter container will be emptied once per rental period for a fee of \$50.00. Each additional dump will cost \$50.00.
3. Customers must sign service agreement before the container will be delivered.
4. The following items are not allowed inside the container: tires, televisions, computer monitor, computer tower, computer accessories, liquids, paint, appliances, chemicals, or hazardous waste. Small amounts of construction or remodeling waste will be acceptable, excluding concrete, shingles, bricks or dirt. No glass or fluorescent light bulbs allowed.
5. Items placed in the container should not extend beyond the dimensions of the container in any direction.
6. The Litter Critter is available for sporadic commercial use only, and not for reoccurring use.

7. Customers must have a City of Lufkin water/sanitation account in order to rent a container.
8. Have container accessible for collection when scheduled for service.
9. The City of Lufkin will not be responsible for damage to drives, parking lots, sites, or vehicles.

**Items Prohibited from Containers:**

(Pursuant to City Ordinance 50.28)

- (A) It shall be considered an offense for any item to be placed in dumpsters that, because of size, weight, or any other physical property, could cause damage to the collection vehicle. These items include, but are not limited to, any one item over three feet in any dimension, or any one item in excess of 50 pounds, any concrete, bricks, dirt, blocks or other earthen material. These items shall be placed in a roll-off container for disposal.
- (B) Tires will not be accepted. If tires are collected undetected, the customer will be charged \$5.00 per small tire and \$8.00 per large tire.
- (C) Persons, business, or other entities placing such items in containers for collection will be required to remove these items before collection can take place.

If any of these conditions exist or persist, the city could suggest alternatives or refuse service until the situation is corrected.
